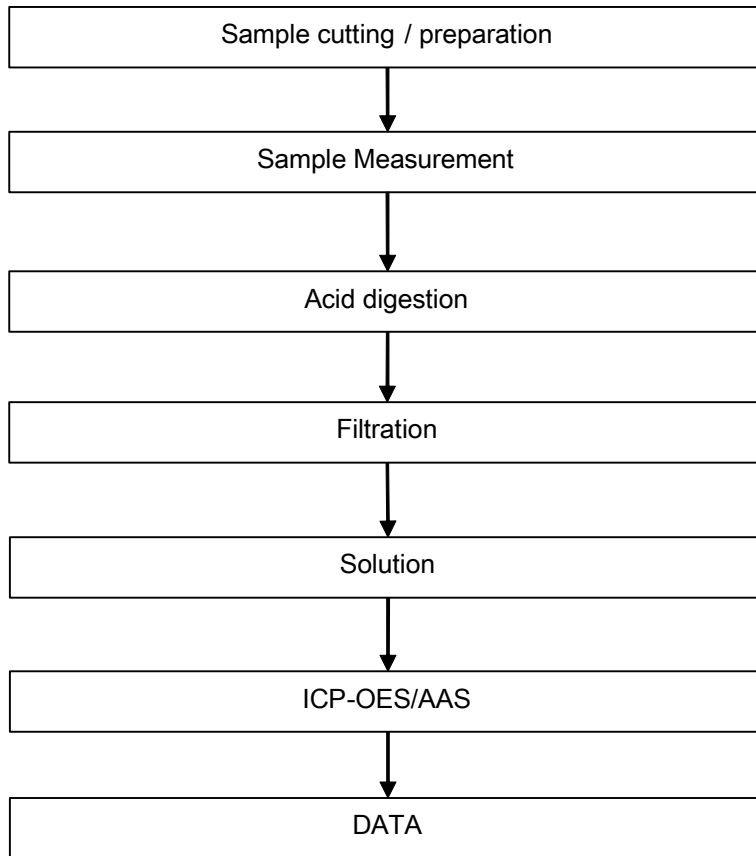

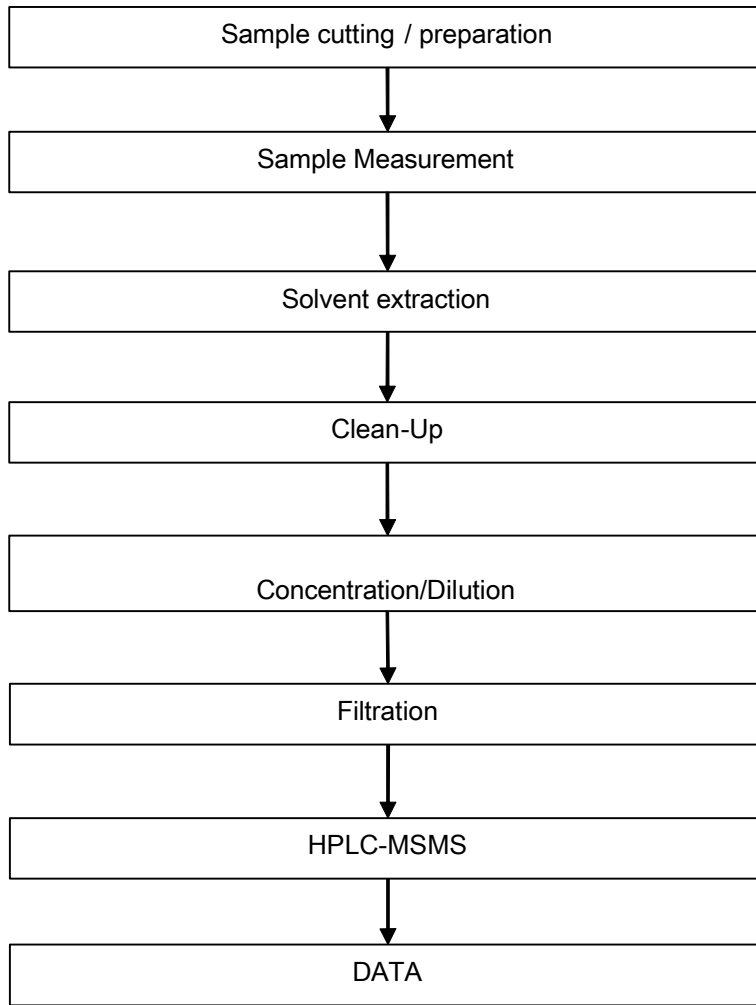

BPA Testing Flow Chart



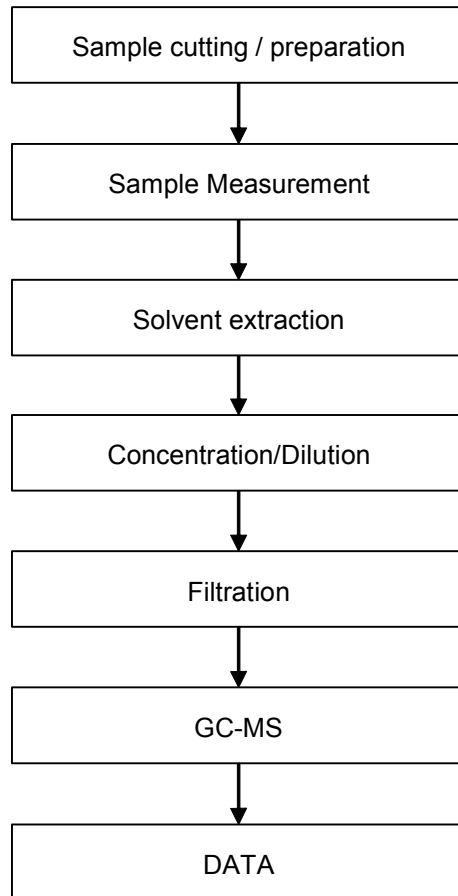

### Phthalates Testing Flow Chart

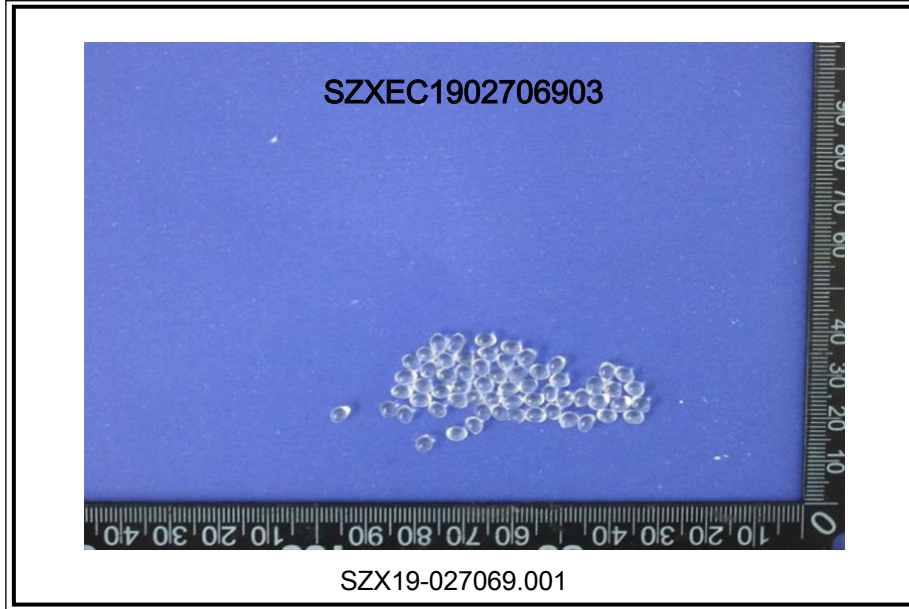
