

# 美国 ECCN 分类与管理实务

**US ECCN Classification and Management Practice**

## 课程背景 Background

美国对高科技产品和技术的出口管制,是通过美国商务部工业与安全局设计的 ECCN 制度来推行的。ECCN 是根据商品管制清单 (CCL) 在 EAR(美国出口管理条例,U.S. Export Administration Regulations)中使用的由字母和数字组成的分类编号,用于识别各商品,以进行出口控制。近年来,以ECCN 为主要措施的贸易管制更是逐步加强和细化,ECCN目前已将管制责任延伸到代理商和进出口贸易商,甚至海外的分销商,强制性地加入到国际贸易流程的各个环节中。中国企业自美进出口货物时,无论何种方式进行,都应熟悉和掌握美国有关贸易管制措施。

ECCN 制度庞大而繁琐,其技术标准、流程与当今全球商业环境、贸易格局完全脱节,在具体实施中遇到了相当大的挑战。中国进口、分销、货运代理及报关等行业的专业人士应及时跟踪 ECCN 领域的进展。基于此,锋信环球特别推出了"美国 ECCN 分类与管理实务"课程。本次课程将带领大家全面学习 ECCN 相关的内容,包括管理清单、国家等级图表、出口控制等级编码架构等,帮助大家了解 ECCN 管制措施,并能够确定 ECCN 编码是否属于出口控制产品,从而及时规避 ECCN 管制措施可能引发的潜在风险。

The export control of high-tech products and technologies in the United States is carried out by the ECCN system designed by BIS. ECCN is a classification number composed of letters and numbers used by CCL in EAR. It is used to identify various commodities for export control. In recent years, the trade control with ECCN as the main measure has been gradually strengthened and refined. ECCN has now extended the control responsibility to agents and import and export traders, and even overseas distributors, enforced into various links of the international trade process. No matter how the Chinese enterprises import and export goods from the US, they should grasp the relevant trade control measures of the United States.

The ECCN system is huge and tedious, and its technical standard and process are completely disconnected with the global business environment and trade pattern. There are considerable challenges in its implementation. Professionals in China's import, distribution, freight forwarding and customs clearance industries should follow the progress of ECCN field constantly. Based on this, Ficient Global will specially host the course titled "ECCN Classification and Management Practice". The course will lead participants to fully learn about ECCN related content, including CCL, the Country Chart, ECCN Structure, to help participants understand the ECCN controls and to determine whether ECCN codes belong to export control products, thus avoiding the potential risks that may arise from the ECCN controls.
