课程背景 Background:



2018年8月1日,美国商务部下设的产业和工业安全局宣布增加44家中国企业列入出口管制实体清单。BIS指控17家公司被涉嫌非法采购商品和技术用于在中国进行未授权的军事用途;指控27家公司有"不可接受"的风险使用或转移美国商品用于在中国开展军事用途。

事实上,美国对于中国实行了更加严格的出口管制。中国有大量机构与个人在美国各政府机构的出口限制清单,均需要申请"出口许可证"才能进口,并且美国拒绝通过"许可证例外"的形式豁免这些产品的出口管制。此外,相对于美国的盟友甚至是印度之类的非盟友国家,不论是在受管制原因类型上,还是在许可证豁免的条件上,甚至是许可证申请的通过率与时效上,中国都受到了更多的限制。因此,美国政府对于出口管制及相关交易的规则和限制,对于中国企业而言,是需要引起充分重视和认真对待的合规性课题。

On August 1, 2018, the Department of Commerce's Bureau of Industrial and Industrial Safety announced the addition of 44 Chinese enterprises to the Entity List. BIS accused 17 companies of illegally purchasing goods and technology for unauthorized military use in China, and 27 companies of "unacceptable" risk of using or transferring U.S. goods for military use in China.

In fact, the United States has imposed stricter export controls on China. A large number of Chinese institutions and individuals are included in the list of export restrictions imposed by U.S. government agencies. They need to apply for an "export license" to import. Furthermore, the U.S. refuses to exempt these products from export control through the form of "license exception". In addition, China is subject to more restrictions than its allies in the United States or even non-allied countries, such as India, whether in terms of the types of regulated reasons, the conditions of license exemption, or even in terms of the passing rate and timeliness of license applications. Therefore, the U.S. government's rules and restrictions on export controls and related transactions are a matter of compliance for Chinese companies.

Based on this, Ficient Global will specially host the course titled "US Export Control and Embargo Regulations and Practice". The course will cover various aspects related to US export controls to help participants understand relevant compliance knowledge and experience and adapt to more diverse and stricter regulatory environments as well as prevent and avoid potential risks timely. The course will be delivered by an expert from a well-known multinational company through presentations and interactive discussions.


